

MIDWEST WOMEN'S TOURNAMENT 2017 CAPTAIN'S INSTRUCTIONS

IMPORTANT: Please review this information and share with all team/doubles/singles bowlers on your entry.

CAPTAIN: If you **move or change your address** AFTER entering the tournament, please forward your new mailing address to the tournament manager, Mary McClay, Ohio USBC WBA, PO Box 752048, Centerville, OH 45475, marymccclay@aol.com, fax 937-436-2699 or at the team check-in office.

RULES: The rules were included on your original entry form and should have been retained by the captain. The entry form including the rules is available at www.midwestwomensbowling.com.

CHECK-IN:

Team Event – PLEASE check in at least 60 minutes prior to squad time to ensure ample time for signup for brackets, purchase of cash raffle, and shopping the concession stand. Only the captain with all 4 team members current USBC cards is required at check in.

Doubles & Singles – Check in **ONE HOUR** prior to scheduled squad time. Partners should check in together. Bowlers must present current USBC card at time of check in.

PHOTOS: Photos will be taken at team and doubles/singles. Photos will be available for purchase and will be delivered before the squad completes.

SUBSTITUTES: Please make every effort to secure your own substitutes! If assistance is needed, contact the Ohio USBC WBA office. There will be a limited number of substitutes available. Email, fax, telephone, or mail substitution forms/information to the Ohio USBC WBA office as soon as possible prior to scheduled bowling date. Last minute substitutions must be done at the tournament office at least **2 hours** prior to the scheduled bowling time.

RECAPS: Bowlers will record the scores on the recaps. The bowling centers will supply a printout of scores from each squad for verification by tournament office staff member(s). Please write neatly. Team captains will sign the team recap; both bowlers with sign the doubles and singles recaps.

COMPLAINTS: All complaints regarding the tournament operation must be brought to the attention of the Tournament Official in charge. Any complaint regarding errors in scoring should be reported to the tournament office at the bowling center or to the Iowa State USBC WBA office within 48 hours after bowling is completed.

DISQUALIFICATION: Any unruly or inappropriate behavior from the use of alcohol or from any other cause will be grounds for immediate disqualification from the tournament.

SMOKING: Smoking is not allowed during tournament competition (please refer to Rule 14).

DELAY OF GAME: Bowlers must be up to bowl when it is their turn, or they will receive a zero for any and all frames missed.
